All Posts are required to re-validate annually by 21 May. Please do this online at [WWW.AMVETS.ORG](http://WWW.AMVETS.ORG). Click on Post revalidation and fill in all blocks. Once validated, an email will automatically be sent to the Dept of Florida Executive Director. If you do not check one of the boxes on the last page concerning the CBLs, it will not be sent forward and the validation is not complete. Once complete, send current 990 and Insurance Accord 25 to National at [www.membersupport.org](http://www.membersupport.org) to update the insurance Accord 25 date listed on the first page of the validation; also send one copy to the Department Executive Director along with your Articles of Incorporation. Note: Only National can update the date on the Accord 25. Having problems with validation, contact the Dept Executive Director.

If you are having problems logging into the National AMVETS website, it is most likely because your email is not correct in the database. The database uses your email on record and your seven-digit ID number to identify you and allow your login. If you know it is correct, then you are probably blocked and you will have to contact member support to get unblocked.

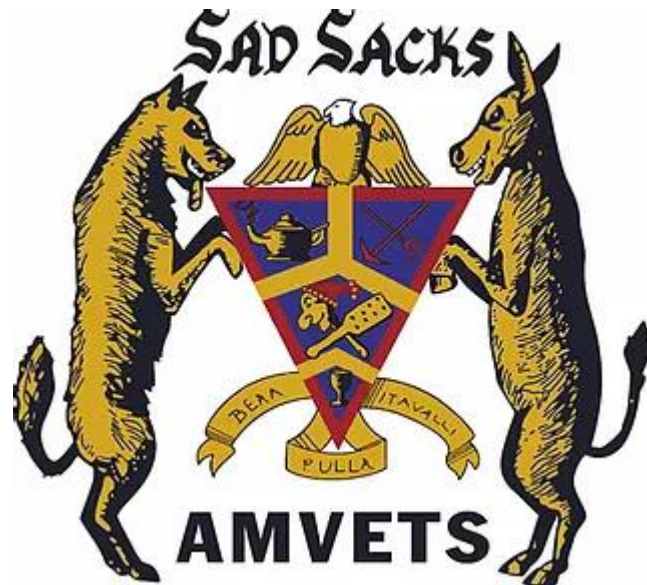
